Be It Enacted by the Legislature of the State of Idaho:

STATEMENT OF PURPOSE

The Idaho Commission on Human Rights was intended as a broadly based citizens committee aimed at resolving claims of discrimination within the state of Idaho. At present participation in the commission is limited to those persons who can afford to contribute their time for minimal compensation. This legislation would remedy this problem by providing for \$25 per day honorarium payments and per diem for commission members when on official business of the Commission.

FISCAL IMPACT

\$4,900 has been budgeted to accomplish the provisions of this act.

STATE AFFAIRS COMMITTEE

FIRST REGULAR SESSION

FORTY - THIRD LEGISLATURE

The STATE AFFAIRS Committee met Friday, February 14, 1975 in the Caucus Room.

The roll call showed all members present, except Senators Ellsworth and Kinghorn, excused.

S. 1022 - This bill relates to voting by mail and Senator Murphy stated he would like to let it have a run on the floor. Senator Yarbrough moved and Senator Murphy seconded a motion to send this bill to the Fourteenth Order of Business for amendment. The motion passed unanimously. Senator Murphy will draft the necessary amendments.

RS 2079 - This bill relates to biennial sessions and is sponsored by Senator Watkins. The committee unanimously agreed to consider it Monday.

RS 0005 - This bill was presented by Mr. Wayne York of the Idaho Education Association and relates to legislative pay. Senator Murphy moved and Senator Batt seconded a motion to hold this bill until Monday for further study. The motion passed with Senator Summers voting nay.

RS 0054 - This bill provides that no public utility shall by contract or otherwise directly assess the costs of construction or any part thereof to its customers without the express approval of the Public Utilities Commission. Senator Murphy moved and Senator Smith seconded a motion to have this bill printed. The motion passed unanimously.

Gubernatorial Appointments - Senator Barker appeared before the committee and stated that Dr. Jim Bax whose appointment as Director of the Health and Welfare Department had appeared before the Health, Education and Welfare Committee and had satisfactorily answered the questions that had been raised in opposition to his confirmation and that that committee would now go on record as not opposing the confirmation proceedings. Senator Chase moved that Dr. Bax's appointment be sent to the floor with recommended confirmation. Senator Smith seconded the motion and it passed unanimously.

S. 1112 - This bill was discussed with Mr. Dan Peters of the Western Idaho State Fair Board appearing to speak in favor of it. Senator Murphy moved and Senator Chase seconded a motion to send this bill to the floor with a do-pass recommendation. The motion passed with the following roll call vote:

S. 1005 - This bill relates to the cottage site leasing program. Senator Chase and Senator Swenson reported they have their proposed amendments worked out and are ready to report this bill to the floor. Senator Chase so moved, seconded by Senator Swenson that this bill go to the Fourteenth Order of Business for amendment. The motion passed unanimously.

S. 1108 - This board relates to placing the Log Scaling Practice Board under the self-governing agencies. Senator Saxvik moved and Senator Smith seconded a motion to send this bill to the floor with a do-pass recommendation. The motion passed unanimously and Senator Chase will be the floor sponsor.

Gubernatorial Appointments - The chairman stated he had received across the desk the following Gubernatorial Appointments:

Mr. Blaine Evans to the Personnel Commission and Dr. Willard Godfrey and Mr. Wynne Blake to the Fish and Game Commission. The committee unanimously agreed to send Mr. Evans appointment to the floor with recommended confirmation and to refer the other two to the sub-committee for study.

RS 0003 - This bill would amend S. B. 1015, previously passed by this session of the Legislature relating to an exemption from the provisions of the emergency daylight saving time energy conservation act of 1973. Senator Saxvik stated that there was an urgency in getting this situation taken care of so that Idaho can go into daylight saving with the rest of the nation February 22. Senator Murphy moved and Senator Chase seconded a motion to send this bill for print and move it down the calendar on suspension of rules. The motion passed unanimously.


RS 2075 - This legislation corrects numbering of statutory sections which occurred during executive reorganization and further provides that expenditures from the present "retained risk fund" may be used for the payment of premiums and the cost of maintaining the operation of risk manager. Senator Batt moved and Senator Saxvik seconded that the committee agree with the recommendation of the Commerce and Labor Committee and send this bill for print and referral back to that committee. The motion passed unanimously.

RS 2353 - This bill relates to records to be left to the Idaho Historical Society. Senator Murphy moved and Senator Saxvik seconded a motion to print this bill. The motion passed unanimously.

RS 2395 - This bill would provide for per diem allowances for the Human Rights Commission members. Senator Batt moved and Senator Saxvik seconded a motion that this bill be printed. The motion passed unanimously.

The chairman stated that earlier in the meeting S. 1112 was sent to the floor with a do-pass recommendation. He had further stated that no issues of controversy would be considered this day because two members of the committee were excused. He stated that he was rescinding the action of the committee in sending this bill to the floor and would ask that it be held for consideration when the entire committee was present.

The meeting was adjourned.

FORTY - THIRD LEGISLATURE

The STATE AFFAIRS Committee met Monday, February 24, 1975 in the Caucus Room.

Roll call showed all members present.

S. 1173 - This bill would provide per diem allowances for the Human Rights Commission. Senator Murphy moved and Senator Smith seconded a motion to send this bill to the floor with a do-pass recommendation. The motion passed and Senator Murphy will be the sponsor.

RS 0040 - The chairman presented this bill to the committee, from the Commerce and Labor Committee who requested it be printed and referred back to them for discussion. It relates to exemptions from the workmen's compensation law, by striking the exemption from coverage for persons engaged in agricultural pursuits. The committee briefly discussed which committee would be germane to this situation if the bill was sent for print. Senator Chase moved and Senator Batt seconded a motion to print this bill and refer it to the Agricultural Committee, stating they felt this would be the germane committee for further discussion of the merits. The chairman stated he really didn't think this was proper procedure since the bill came from Commerce and Labor and if it were printed and referred to any committee other than State Affairs, it should go to the committee that first recommended it. Senator Chase and Senator Batt withdrew their motion and Senator Saxvik moved and Senator Chase seconded a motion to print the bill and refer it to the State Affairs Committee. The motion passed with Senator Ellsworth, Senator Yarbrough and Senator Swenson voting nay.

S. 1185 - This bill would prohibit smoking in public places. Senator Chase moved and Senator Murphy seconded a motion that this bill be held in committee. Senator Batt offered a substitute motion, seconded by Senator Kinghorn that this bill be sent to the floor without recommendation. The motion passed with the following roll call vote:

Senator Murphy will sponsor this appointment.

Rep. Reardon moved that the minutes of March 11 be approved as presented; Rep. Danielson seconded the motion. Motion carried.

RS 1945 WORKS OF ART IN PUBLIC BUILDINGS. Suzanne Taylor, the Executive Director, Arts and Humanities Commission, met with the committee to present this bill. The bill had previously been considered by the committee and returned to the sponsor on January 21. Mrs. Taylor said the initial bill had been amended to provide in Section 2 that "no individual project appropriation for acquisition of works of art shall exceed \$25,000." She said the bill was also amended to provide for preference to be given to Idaho artists. Rep. Ingram expressed concern that the bill could permit valuable works of art to be placed in offices out of public view. Mrs. Taylor said the intent of the bill and the guidelines relating to its administration would not allow this situation. Rep. Reardon expressed concern with the provision in Section 2 of the bill that all state departments "shall" expend these funds for works of art. He felt it should be optional. Mrs. Taylor said she would not object to this amendment.

Discussion was held on the bill.

Motion Rep. Reardon moved that RS 1945 be introduced after being processed through WTST to provide that all state departments "may" expend the funds; Rep. Wheeler seconded the motion. Discussion was held on the motion. Motion carried.

SB 1030aa ADVISORY VOTE BY ELECTORATE ON CONSTITUTIONAL AMENDMENTS.
This bill was considered by the committee prior to recess but no recommendation was made.

Motion Rep. Miller moved that SB 1030aa be returned to the desk with a recommendation it Do Pass; Rep. Reardon seconded the motion. Discussion was held on the motion. Rep. Wheeler said he felt the bill should have an exclusion to allow the Legislature to ratify proposed amendments such as the ones pertaining to succession to the presidency. Rep. Hosack said he thought the language of the bill should be changed to strike the words "shall not in any case ratify" the amendment to the U. S. Constitution; he said it would place a restraint upon the Legislature inasmuch as the Supreme Court has held it is the Legislature's prerogative to ratify an amendment. Motion carried. Rep. Reardon will sponsor the bill.

under certain conditions when federal law permits. These benefits would be financed by 50 per cent state unemployment trust fund moneys and 50 per cent federal funds. In reply to a question from the Chairman, Mr. Beaman said the extended benefits could apply for an additional thirteen weeks, for a total of 32 weeks.

The Chairman announced that this bill would be before the committee at the following meeting for consideration.

HB 273 BUREAU OF MINES AND GEOLOGY. Mr. Teske met with the committee to discuss this bill. It would designate the Bureau of Mines and Geology as a Division and would also provide for the formation of an advisory board. Some members of the committee expressed concern with designating the Dean of the School of Mines at the University of Idaho as the chief administrative officer of the Division without adequate funding and personnel.

Motion Rep. McDermott moved that HB 273 be held for further study; Rep. Hosack seconded the motion.

Motion Rep. Ingram made an amended motion that HB 273 be held for one legislative day; Rep. Beardon seconded the motion. Discussion was held on the motion. A division was called for resulting in 8 ayes, 6 nays. The amended motion carried.

SB 1173 HUMAN RIGHTS COMMISSION HONORARIUM. Rep. McDermott requested that this bill be considered by the committee.

Motion Rep. Beardon moved that SB 1173 be considered by the committee at 9:00 a.m. March 13; Rep. Lewis seconded the motion. Motion carried.

The meeting was adjourned at 10:10 a.m.

Rep. Danielson moved that the minutes of March 12 be approved as presented; Rep. Beardon seconded the motion. Motion carried.

SB 1173 HONORARIUM FOR HUMAN RIGHTS COMMISSION. This bill would provide for an honorarium in the amount of \$25 per day for the members of the Human Rights Commission while on official business, in addition to reimbursement for traveling expenses. Considerable discussion was held whether the term "honorarium" was appropriate in this legislation or whether "compensation" should be used. Some members questioned whether an honorarium would be reportable income. Joe Welch from the Governor's staff met with the committee to discuss this bill. He said that "honorarium" or "compensation" could be used interchangeably in this bill; he also said the fiscal impact was estimated to be \$4,000.

Motion Rep. Danielson moved that SB 1173 be returned to the desk with a recommendation it be placed on General Orders for Amendment to state that the Commissioners be paid "compensation" rather than an "honorarium". The motion died for lack of a second.

Motion Rep. Bunting moved that SB 1173 be returned to the desk with a recommendation it Do Pass; Rep. McDermott seconded the motion. Motion carried. Rep. Bunting will sponsor the bill.

HB 273 BUREAU OF MINES AND GEOLOGY. This bill would designate the Bureau of Mines and Geology as a Division and would also provide for the formation of an advisory board. It had been held for one legislative day at the previous meeting. Discussion was held on the bill. Concern was expressed by some members whether the Dean of the School of Mines at the University of Idaho should be designated as the chief administrative officer of the Division.

Motion Rep. Lewis moved that HB 273 be returned to the desk with a recommendation it Do Pass; Rep. Bunting seconded the motion.

Motion Rep. McDermott made an amended motion that HB 273 be held for further study; Rep. Wheeler seconded the motion. Discussion was held on the amended motion. Some members felt the opinion of the Dean of School of Mines should be received before action by the committee. Others questioned whether the bill could receive proper consideration this late in the session.

I have the honor to advise that I have transmitted to the Secretary of State without my approval, disapproved and vetoed the following Senate Bill, to wit:

SENATE BILL 1154

within the time limit by law, the same having been delivered to the Office of the Governor at 2:38 p.m., March 21, 1975, and the Legislature by adjournment sine die having prevented the return of the bill for reconsideration to the House in which it originated.

Senate Bill 1154 as proposed prior to amendment, amended Section 26-1930(3) wherein property improvement loans made pursuant to the National Housing Act and other loans, secured or unsecured, to homeowners and other property owners, subject to a maximum of \$5,000 be payable in monthly installments over a period not to exceed 62 months for the maintenance, repair, alteration, modernization, landscaping, improvement, new construction and furnishing or equipment in connection therewith, of their properties, was proposed to increase from the \$5,000 amount to \$10,000 for the same period of time, 62 months. However, the amendment to SB 1154 changed the 62 months to 180 months. The bill as amended to 180 months would create a severe hardship on the citizens in the event the lending institution should write a loan to the maximum number of months, in this case 180, as shown by the following comparison:

\$10,000 at 10% for 62 months equals monthly payments of \$207.21. This would result in the borrower repaying \$12,847.12 of which \$2,847.12 would be interest.
\$10,000 at 10% for 180 months equals monthly payments of \$107.47. This would result in the borrower repaying \$19,344.60 of which \$9,344.60 would be interest.

The National Housing Act now allows, under FHA Title I, home improvement loans to be written for a maximum amount of \$10,000 for a period of 12 years at a rate of interest not to exceed 12%. This bill as amended results in an obvious hardship to any citizen who would obtain such a loan for a 180 month period, or 15 years, by paying an excessive amount of interest.

The item disapproved is as follows:

On page one of the bill, the following is vetoed and disapproved:

"SECTION 3. In the event that the amount of federal funds received by the Idaho Bicentennial Commission is in excess of those appropriated in section 1 hereof, the general funds appropriated in section 1 shall be reduced by such excess and shall revert to the general fund."

The practical result of the vetoed language would be to prohibit the commission from seeking additional federal
